Subject: Notification of the Resolution of the Bondholders' Meeting No. 1/2020 (TLUXE205A)

As PP Prime Public Company Limited (Formerly known as Thai Luxe Enterprise Public Company Limited) (the "Company") held the bondholders' meeting (TLUXE205A) no. 1/2020 on the 27 February 2020 at 10.00 hrs. at the Galleria Room, Floor 5, S31 Sukhumvit Hotel, with Siam Commercial Bank (SCB) as the bondholder's representative. The Company acted as the Chairman of the meeting to consider and approve the amendment of terms and conditions of bond issuers and bondholders. The meeting has resolved as follows:-

1. Resolved to approve the amendment of the terms and conditions of the bond issuers and bondholders and to extend the maturity date of the bond No. 1 (TLUXE205A) from the original date of 8 May 2020 to 8 May 2021.

2. Resolve to approve the amendment of terms and conditions of the bond issuers and bondholders by redeeming the shares of Star Universal Network Public Company Limited ("STAR") that the Company owns and as the guarantee for bond (TLUXE205A). The Company will sell those via the Stock Exchange of Thailand and pay for debt to bondholders of Baht 60 million.

3. Resolve to approve the amendment of terms and conditions of bond issuers and bondholders with the exception to maintain the debt to equity ratio (D/E Ratio) from the originally specified at the D/E Ratio of 3 : 1 to no longer fixed the condition of D/E Ratio.
