The conversion price is not less than 90 percent of the said weighted average price. Therefore, it does not meet the criteria to prohibit the sale of shares within 1 year from the date of receiving the convertible securities (Silent Period). In this regard, the Company offered for sale and issued convertible debentures No. 1/2029 on 15 January 2026 in the amount of 3 million baht (3,000 units). The convertible debenture holders exercised the remaining conversion rights on 18 February 2026, amounting to 1 million baht (1,000 units). Consequently, there are convertible debentures of 1 million baht (1,000 units).
